- Has a good testimony at home, on the job and in his neighborhood and local church as reflected by both speech and conduct.
- Is actively involved in a local church.
- Is continually learning to trust the Lord for victory, wisdom and guidance.
- Is willing to submit to biblical authority.

SPECIFIC QUALIFICATIONS FOR A CEF LOCAL COORDINATOR/LOCAL DIRECTOR
